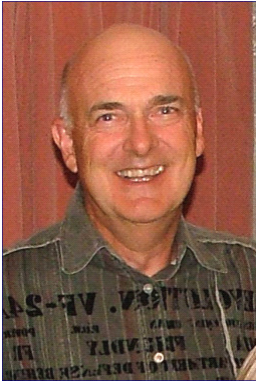
## MESSAGE FROM DG LYN

## June 2012

### President:

- ◆ Nominations for District Governor 2012/2013, 1st and 2nd Vice District Governor 2012/2013 and Host Club for the 2014 District Convention, and Directors of Foundations and Institutes must be received by the Cabinet Secretary 60 days prior to the date of the next District Convention. Has your club submitted nominations?
- ◆ Finalise arrangements for the Club's Installation Night, with a full agenda/programme including a list of members designated for various duties on the night.
- ◆ Does your New President have their President's Kit from District Administration?
- ◆ *Done a good job?* Have your Secretary fill out the claim form for your President's Excellence Award without delay-they should have received the form in their Secretary's Kit at the beginning of the year. Have the Zone Chairman sign it before sending to the Cabinet Secretary.

### Secretary:

- ◆ **ELECTRONIC MMR'S and Activity reports go to** <https://www3.lionsclubs.org/EN/RegisterLogin/HomeLogin.aspx> and follow links. Last day 21st.
- ◆ Notices of motion of a project nature must be received by the Cabinet Secretary 90 days prior to the District Convention and Notices of Motion of an Administrative nature 60 days prior to the Convention.
- ◆ With Incoming Secretary, check that the Club has full supplies of forms, badges, New Members Kits, etc. and that filing member's information, etc. is completely current for your year as Secretary. Does your new Secretary have the 2012/2013 Secretary Kit from District Administration along with the latest copy of the Club Administration Manual from Multiple Districts (can be downloaded from website).
- ◆ Advise members of the Multiple District 201 Convention decisions.
- ◆ *Done a good job?* Apply for the District Club Secretary's Award?

### Treasurer:

- ◆ Make arrangements for the audit of your Club accounts in July, and with your new Club Treasurer send out Dues accounts for the first 6th Months of the new Lions Year.
- ◆ Make sure that your Incoming Treasurer has an end of the year balance for all accounts (unaudited if necessary) and cheque books and all necessary equipment for the year ahead. Have the bank signatories been charged?

As President and Chief Executive Officer of your Lions Club for the coming year, members will depend on YOU for Direction.

Members will measure your performance in terms of personal satisfaction and enjoyment, especially at meetings.

To achieve success the President needs to show enthusiasm, vigour and dedication to the position. Be well prepared, and continually work to extend knowledge. That way there is every opportunity to be seen as leader, a motivator and an organiser.

Success depends on good planning and preparation.

Good communication is important too . . . keep people informed all the time.

On the occasions when your skills , and patience, are tested remember, that you have your members to help you, and that the Zone Chairman, District Governor, Cabinet Officers and other experienced Lions may be called on for assistance.

## CLUB TREASURER

### DUTIES OF THE CLUB TREASURER.

The Treasurer is the financial officer of the Lions Club and his/her official duties are under the supervision of the Club President and the Board of Directors:

The Duties of the Treasurer include:

- ◆ Receiving all monies, which are to be banked into the accounts approved by the board of Directors.
- ◆ Issue Cheques (*Never Cash*) in payment of Club obligations on the authority of the Board of Directors, Cheques must bear the Treasurer's Signature and one other authorised club official
- ◆ Prepare and submit financial reports for the Board and club meetings on a regular basis (*at least monthly*).
- ◆ Serve on the Club Finance Committee, usually as Chairman
- ◆ Prepare an Administration budget at the beginning of the year
- ◆ Maintain a ledger of money owing and received for each Club member.
- ◆ Ensure that the books are audited and that all necessary reports have been lodge with District Cabinet and others as required.
- ◆ Hand over to your successor all books, documents, Club property and ensure bank account signatories have been changed at the bank.

## CLUB MEMBERSHIP CHAIRPERSON

Membership Chairman are seen as an integral part of the team in this District. You are asked to attend INCOMING OFFICERS FORUMS AND DISTRICT GOVERNORS ADVISORY MEETINGS (*or Zone meetings*).

### MAIN DUTIES:

- ◆ Membership Growth-the addition of new members.
- ◆ Membership Development & Retention-Education.
- ◆ Ensuring Sponsors are briefed on their responsibilities.
- ◆ Nurturing a team environment and ensuring support for members when they need it.

*Always remember assistance can be obtained from District Global Membership Team (GMT) Coordinator and the members of the Global Membership Team - for details view the Multiple District Directory.*

## May 2012

### President:

- ◆ Continue training the Incoming Club President, Secretary and Treasurer. You will have received details of the Incoming Club Officers' forum date from the Zone Chairman. Please ensure incoming President, Secretary, Treasurer and Membership Chairman attend **EVEN IF THEY HAVE HELD THE POSITION BEFORE.**
- ◆ Plan details of Installation Night for Club Officers. Keep the following in mind.

Please ask your Board of Directors to consider carefully the wording of motion(s) to be brought forward at the District Convention.

## CLUB PUBLIC RELATIONS

Public relations involves all forms of communication-written, verbal and non-verbal. It includes writing news releases and distributing promotional flyers etc. Equally important are actions taken for granted, such as wearing a Lions Club T-Shirt, Lapel Pin. Good public relations-informing the community that your club has conducted projects like Vision Screening, Supported local students in sporting opportunities etc.

Remember Public relations can even support your Club's membership efforts. People want to belong to a successful and reliable organisation. By actively promoting your club and its worthwhile activities, you'll be projecting a positive image in your community and showing that your club's worth joining.

### DUTIES:

- ◆ Communicate information about your club to the community.
- ◆ Keep your club aware of PR efforts and results.
- ◆ Make a time frame determine how and when you will promote your club, note your DG's Annual Membership Month
- ◆ Provide information to International Headquarters about outstanding programs and activities of your club, which might be of interest to regional and national media.
- ◆ Supply information to DG's Bulletin Editor or to editor of "The Lion" a good story is always worth telling.

## ZONE CHAIRPERSON

Remember you are the Key contact to the clubs on behalf of the District Governor and the District. Report to the District Governor promptly, any problems that are brought up at your advisory meetings with respect to clubs. You have a Zone Chairman Manual and you have responsibility to see that clubs are providing necessary reports to District and Multiple District.

Remember that you are required to submit a report on every club you visit - the forms for these reports can be found on the District website and sample is in your Zone Chairman Manual

## DISTRICT LEADERSHIP & TRAINING

**On a directive from LCI the MERL Team as we know has been revamped into the Global Leadership (GLT) & Global Membership (GMT) Teams. A brief description of each follows for your information.**

### **District GMT and GLT Coordinators & Teams**

There shall be separate GMT and GLT Teams at the district level, both of which will be anchored by the DG Teams at the center of each team, serving and advising on both teams.

There shall be one coordinator each for District GLT and GMT teams. However if two suitable persons cannot be identified, one person may be appointed to handle both coordinator positions if no other options exist. Below is an overview of the structure for both.

GMT will of course pursue membership growth and new club development while GLT will focus on ensuring training of all leadership levels - from club officers on up -- to ensure that clubs and districts are truly operating in a way that will help us retain and attract more members.

Together, GMT and GLT shall be highly interdependent teams working in tandem, interacting continuously and intensively at all levels. One cannot succeed without the other.

## GLOBAL LEADERSHIP TEAM (GLT)

### **GLT District Team Structure:**

- ◆ District Governor
- ◆ 1<sup>st</sup> and 2<sup>nd</sup> Vice District Governors
- ◆ GLT District Coordinator (3 year appointment required)
- ◆ Other leadership specialists in the district based on local needs.

The GLT District Coordinator shall serve a three-year term.

The 2<sup>nd</sup> Vice District Governor will serve as the DG Team's primary liaison to, and monitor of, the GLT District Team.

### **GLT District purpose and general responsibilities:**

- ◆ Organizes training for Zone Chairs, Guiding Lions
- ◆ Ensures or delivers club officer training annually
- ◆ Implements Club Excellence Process workshops or trains/assigns CEP facilitators to conduct such workshops

## April 2012

### President:

- ◆ Have you arranged your Club's Installation Officer, and made all other necessary arrangements for the Changeover Night?
- ◆ Start Training Incoming Club President, Secretary, Treasurer and Membership Chairman, and strongly encourage them to attend the Incoming Club Officers' Forum in your area.
- ◆ Have all members received attendance awards to which they are entitled?

- ◆ Ensures Certified Guiding Lions are properly advising new clubs under their charge
- ◆ Identifies and develops qualified new leaders for club, zone, and cabinet
- ◆ Ensures clubs routinely conduct new member orientation and make development opportunities available to all members
- ◆ Establishes a leadership development plan for district, in consultation with GLT MD Team
- ◆ Adapts LCI orientation materials and club officer training materials, as needed, to meet local needs
- ◆ Promotes the LCI Mentoring Program and recruits Lions to undertaking mentoring process so they become better-prepared future leaders
- ◆ Submits leadership tracking forms to MD and to LCI for input into “future leader” database
- ◆ Promotes the involvement, and use of, LCI leadership institute graduates in functions and program at the district and club level
- ◆ Identifies important community leaders to be involved with Lions (e.g. government leaders, civic leaders, etc); refers them to GMT.

## GLOBAL MEMBERSHIP TEAM

### **GMT District Team structure:**

- ◆ District Governor
- ◆ 1<sup>st</sup> and 2<sup>nd</sup> Vice District Governors
- ◆ A GMT District Coordinator (3 year appointment required)
- ◆ Other membership specialists in the district based on local needs.

The GMT District Coordinator shall serve a three-year term.

The 1<sup>st</sup> Vice District Governor will serve as the DG Team's primary liaison to, and monitor of, the GMT District Team.

### **GMT District purpose and general responsibilities:**

Underneath the core GMT District team, district has appointed a team under two special functions:

- 1) the Membership and New Club Growth action team; and
- 2) the Club Success Team, which will focus on solving the root causes of retention problems and promoting successful clubs.

Districts will be able to record with LCI the names of Lions appointed to serve on the action teams.

## IDEAS TO SPICE UP YOR MEETINGS

We are all aware that lengthy/boring meetings are the number one reason former members cite for dropping out of their Lions Clubs:

CLUB MEETINGS work best if they are stimulating, informative and enjoyable.

To achieve this the President needs to have:

- ◆ An Agenda for a meeting, which would be followed as closely to the minute as possible.
- ◆ A Tail Twister who is able to keep the meeting alive and interesting.
- ◆ A determination to see that meetings are thoroughly planned beforehand and run according to the plan.
- ◆ An ability to keep the meeting moving thus avoiding members taking up too much time with unnecessary topics.
- ◆ Start and closure of meeting always on time
- ◆ Adequate meeting facilities.

Other suggestions:

1. Visit another club or share in the same activity
