**Scuba diving and helicopter rides are extra optional activities available when on the Great Barrier Reef Trip.**

**Both these activities are an extra cost: scuba diving \$120 and helicopter rides \$150 (Approx) being payable to the tour operator on the day.**

**Note that snorkelling, meals and other activities on the GBR trip are included in the camp fee.**

**Students will need some pocket money for the above activities if they choose to do them, and out of pocket expenses, souvenirs, personal purchases and possible minor emergencies.**

**REFUND POLICY: Should you be unable to attend camp, our refund policy is as follows:**

- Cancellation received by 20<sup>th</sup> June 2012 100% refund
- Cancellation received by 27<sup>th</sup> June 2012 75% refund
- Cancellation received by 4<sup>th</sup> July 2012 50% refund
- Later cancellation or failure to turn up at the camp. No refund.
